Purchase and take possession of an Apple Macintosh computer and a qualifying version of Final Cut Express HD from January 1, 2007, to March 27, 2007, and qualify for \$200 via mail-in rebate. Qualifying products must be purchased together on the same sales receipt from an Apple Authorized Reseller located in the 50 United States or the District of Columbia. Purchases made at the online Apple Store, a retail Apple Store, or through Apple Telesales qualify for an instant discount and are not eligible for the mail-in rebate. Purchases made through Apple Authorized Campus Resellers are ineligible for this offer. This offer is for end customers only. Reseller and institutional purchases do not qualify for this offer.
